Meeting called to order by Chairman, Tracy McRae

Pledge of allegiance was given and prayer was led by Administrative Secretary.

Motion to adopt the minutes as mailed for the March 11, 2026, meeting with no public comment, by B.J. Guerin seconded by B. J. Clark Vote passed Yeas-6 Nays-none Absent-Vicky Brown

There were no public comments under item 2, so Chairman moved to the next agenda item.

Director, stated that soccer season begins this week and baseball/softball on 4-13-26. He reported on the mulch upgrade around the park for playgrounds, etc. He also reported on playground equipment repairs. He reported on safety training with maintenance staff regarding standards and safety priority.

He noted that the pre-construction meetings for contractors will be on 4-23-26 11am with the Engineer.

He covered the maintenance upgrades being addressed across the park.

He presented 3 fencing quotes for the soccer complex on the new land, noting that the low quote totals \$27,000 by Prime Scape Fence & Stain.

Motion to award the low quote for fencing around the soccer complex in the amount of \$27,000 to Prime Scape Fence & Stain as presented with no public comment by B.J. Clark seconded by B. J. Guerin Vote passed Yeas-6 Nays-none Absent-Vicky Brown

The financial report was presented by the Administrative Secretary for the March, 2026, period of operations and comparisons to budget along with the March bills made.

Motion to accept the March, 2026 financial report and pay the bills as presented for the April period with no public comment by S. Howitz seconded by B.J. Clark  
Vote passed Yeas-6 Nays-none Absent-Vicky Brown

Motion to adopt a resolution to direct Hancock Whitney to remove Chris Prescott and add 3 new board members to the signature approval section on the operations checking account with no public comment by B. Harris seconded by S. Howitz  
Vote passed Yeas-6 Nays-none Absent-Vicky Brown

Chairman, Tracy McRae commented on recent Livingston Parish School Board CEA standards on use of structures for events. A revised CEA with the Recreation District 2 will be presented in the months ahead. Board discussed and agreed to consider a revised CEA when presented.

Under committee comments, B.J. Guerin and B.J. Clark made comments on the Capital Outlay-Soccer-Fitness expansion project. B J. Guerin noted need to honor past board members that have served and donated to make the District a reality. B.J. Clark requested to use an engineer to design the soccer expansion. Board discussed and agreed.

Motion to authorize the engagement of Fairburn & Associates to design the new soccer complex for committee consideration for improvements of the new land with no public comment by B.J. Clark seconded by A. Curtis Vote passed Yeas-6 Nays-none Absent-Vicky Brown

Under board comments, B.J. Clark stated the need for new batting cages near the four plex. He is looking into having shared sponsors to advertise on the cages and pay for the improvement expenses of constructing. He will keep board posted.

Motion to adjourn the meeting with no public comment by B. Harris seconded by S. Howitz Vote passed Yeas-6 Nays-none Absent-Vicky Brown
