Meeting called to order by Chairman, Tracy McRae.

Pledge of allegiance was given and prayer was led by Administrative Secretary.

Motion to adopt the minutes as mailed for the April 8, 2026, meeting with no public comment, by B.J. Guerin seconded by S. Howitz Vote passed Yeas-6 Nays-none Absent-B. J. Clark

Under public comments, Trey Sanders presented the 2025 Financial audit and AUP audit. He summarized the clean unmodified opinion and thanked the staff and Administrative Secretary for their assistance in completing this audit.

Motion to accept the 2025 Financial Audit and AUP audits as presented with no public comment, by V. Brown seconded by A. Curtis Vote passed Yeas-6 Nays-none Absent-B. J. Clark

The financial report was presented by the Administrative Secretary for the April, 2026, period of operations and comparisons to budget along with the May bills made.

Motion to accept the April, 2026 financial report and pay the bills as presented for the May period with no public comment by B. J. Guerin seconded by S. Howitz

Chairman, Tracy McRae commented that the notice to proceed for the contract on the expansion was executed on 5-4-2026.

Under committee comments, there were no comments from Personnel or Capital Outlay Committees.

The Soccer/Fitness Committee members stated that their intention is to proceed with a survey to the public on future needs wished for regarding improvements.

Under board comments, B. J. Guerin noted she will be pursuing a proposal for honoring past founders of the District.
